\$175 plus 25 cents per pillow (Bed size: king, queen, full = 2 pillows; twin & smaller = 1 pillow)

##### RV Parks

\$175 plus \$5 per site

##### Real Estate

\$175 plus \$10 per agent

##### Financial Institutions

\$13 per million in deposits (\$500 minimum)

##### Utilities

\$0.16 per customer

##### Insurance

\$175 plus \$10 per agent

##### Medical Professionals/Physicians/Clinics

\$175 plus \$50 per professional

##### Attorneys

\$175 plus \$50 per attorney

##### Employee Based Members

The updated rate structure is based on the number of full-time employees. (2 part-time employees = 1 full-time employee.) *Example: 12 full-time employees + 24 part-time employees = 24 full-time employees = \$335 per year.*
